No. D. 32019/2/2015-HM(VCS) : In exercise of the powers conferred by section 357-A of the Code of Criminal Procedure, 1973 (Act 2 of 1974), the Government of Mizoram, in coordination with the Central Government hereby makes the following Scheme to amend the Mizoram Victims of Crime Compensation Scheme, 2011 namely:-

1. Short title and commencement

(1) This Scheme shall be called the Mizoram Victims of Crime Compensation (Amendment) Scheme, 2018.

(2) It shall come into force from the date of publication in the official Gazette.

2. Amendment of clause(i) of Para (3)

In the Mizoram Victims of Crime Compensation Scheme, 2011 for clause(1) of para (3), the following shall be substituted, namely -

"Victim" means a person who has suffered any loss or injury as a result of a crime or violence and causing burns or maiming or disfiguring or disabling or causing grievous hurt as a result of acid attacks, sexual assault, mob violence/lynching and require rehabilitation and the expression "Victim" shall include dependent family members.

3. Amendment of Para 6.

After clause (m) of Para 6 of the Principal Scheme, the following clause shall be inserted, namely -

(n) A sum of Rs. 3.00 lakh shall be paid to the victim/dependant of the mob violence/lynching resulting in death or permanent disability.

(o) A sum of Rs. 1 lakh shall be paid as interim relief to the victim/dependant within a period of 30(thirty) days of the incident of mob violence/lynching.

(p) A sum of Rs. 1 lakh shall be paid to the victim in case of partial disability (40% to 80% disability)
